

GENERAL DIRECTIONS

METHYL - BIG 6 is an emulsifiable concentrate which contains 4 lbs. Methyl Parathion and 2 lbs. EPN for use on cotton insects. It is suitable for use in conventional hydraulic sprayers and airplane sprayers. For aerial application, dilute in 3 to 4 gallons of water per acre.

COTTON: For control of thrips, certain spider mites, cotton fleahoppers, boll weevils, bollworms, yellow striped armyworm, and garden webworms apply when insects appear and repeat at 5 day intervals as necessary.

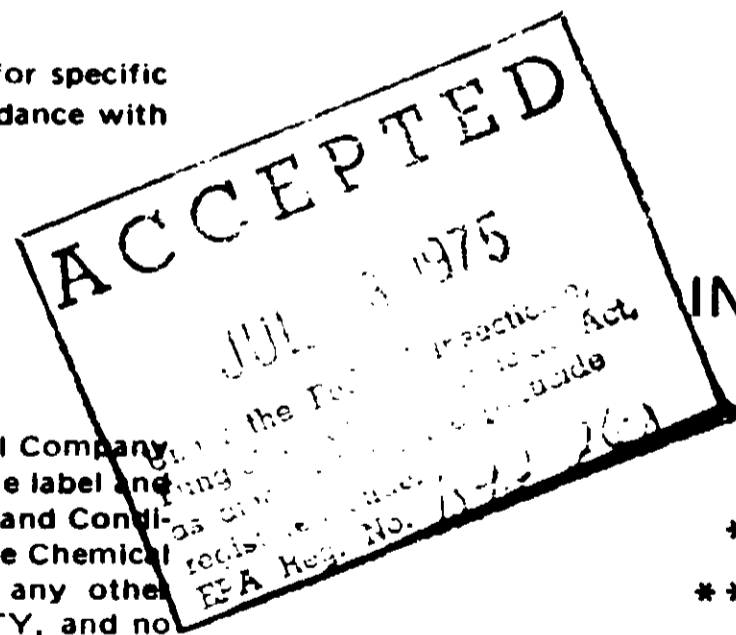
