 - c. In the statement "Fast Acting Leaves No Residue" delete the statement "Leaves No Residue".
 - d. In the statement of Practical Treatment, delete everything except the instructions on what to do if inhaled.

- 3. Submit two copies of the revised final printed label for the record.
- 4. Submit a revised Confidential Statement of Formula which addresses the following concerns:
- a. In item 7, specify the units being measured and verify that the number is correct.
- b. In item 14, the upper limit for piperonyl butoxide has to be higher by weight than the nominal concentration.
 - 5. Please submit for the record the following two documents:
- a. a revised address of record which specifies the company contact.
- b. a revised Certification with Respect to Citation of Data on which neither block is checked on item 2. There is no exclusive use study for this active ingredient.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS FOR USE

Shake well before use. This product must be diluted before use. Shake or stir thoroughly before using or reusing the final diluted emulsified solution.

To control fleas, ticks and lice on dogs and cats, dilute 4 fluid ounces of this concentrate with I gallon of water and mix well to form a creamy emulsion dip. Dip animal into solution being careful to thoroughly wet the hair to the skin. Do not riase. Towel dry. Repeat as necessary.

For control of ear mites, while dipping, lightly sponge inside of ears.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS CAUTION

Harmful if swallowed. Avoid contact with eyes. Do not contaminate food or foodstuffs with this concentrate or dip.
