

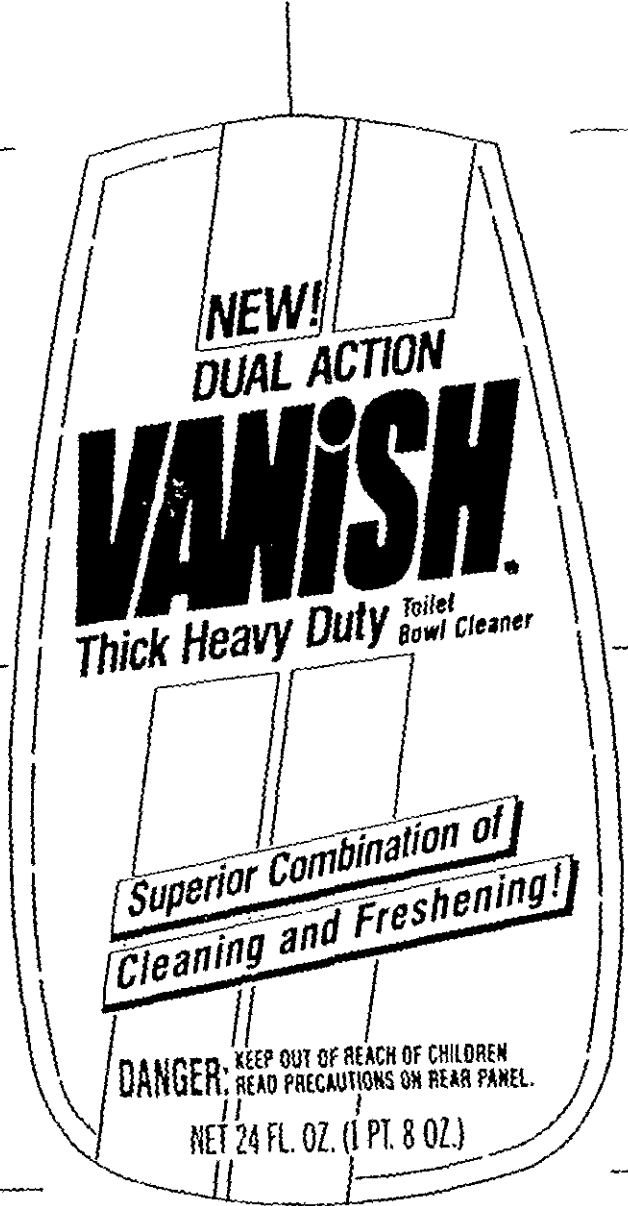

**CAP INSTRUCTIONS:**

**TO OPEN:** Grip bottle near top. Push cap down while turning counter clockwise. **TO CLOSE:** Screw cap on tightly clockwise. When locked, cap will click when turning counter clockwise without pushing down.

**TO DISINFECT AND CLEAN:**

Rinse toilet seat. Direct the thick liquid formula inside bowl, including under the rim, on the sides, and into water. To kill household germs including staph germs, use at least 4 oz. (squares approximately 15 seconds). Leave VANISH in bowl for 30 minutes. Then brush and flush. Rinse bowl brush in fresh water after use.

**DIRECTIONS FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**TO REMOVE STUBBORN STAINS:**

For hard water stains, follow directions above. Then apply more product directly to stained area. Let VANISH stand at least 15 minutes, brush and flush. Repeat if necessary.

Regular use of VANISH keeps toilet bowls sparkling white. VANISH is excellent for brightening colored toilet bowls. VANISH should be used only for toilet bowls. Not recommended for plumbing and septic lines.

**STORAGE AND DISPOSAL:**

Store out of reach of children. Clean up "spills" right away. *(Phosphoric acid)*

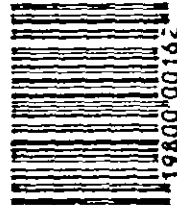
