

Dispense from electric or hand sprayer, or in vaporizing or fog generator. For control of named insect pests in institutions, hotels, restaurants, school cafeterias, home hospitals, clubs, and food processing plants.

For most effective results, use in a good sprayer. Follow manufacturer's recommendations. Remove or cover all food during treatment. Cover all food processing surfaces during treatment and wash them before plant goes back into operation.

Control of these insects is limited to exposed stages.

DIRECTIONS:

FLYING INSECTS: For control of small flying moths, flies, mosquitoes, gnats, wasps, hornets, direct the spray toward the upper portion of the room, filling it with mist. Use 1 ounce per 1000 cubic feet. Keep the room closed for 10-15 minutes, and sweep up and destroy fallen insects. Ventilate the area after treatment is completed. Repeat treatment as necessary.

WASPS AND HORNETS: Application should be made in late evening when insects are at rest. Spray into hiding and breeding places, contacting as many insects as possible.

ANTS AND ROACHES: Direct contact of the insect with the spray, in addition to thorough spraying of all parts of the room suspected of harboring these pests should be made. Special attention should be given to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas, and wherever these pests are suspected of hiding. Treatment of doors, windows, and ant trails is emphasized for the control of ants. Repeat treatment as necessary.

SILVERFISH: Application should include frequent and repeated spraying of baseboards, windows, door frames, book cases and storage areas. Direct contact of the insect is emphasized for adequate control of this pest. Repeat treatment as necessary.

CRICKETS: Application should be made by thorough and repeated treatment behind stoves, refrigerators, under cabinets, in food storage areas and especially in closets. Emphasis should be placed on directly contacting the pest with the spray. Repeat treatment as necessary.

SPIDERS: For control of these pests, liberal and repeated application should be made to the individual pest.

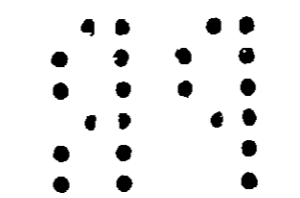
CARPET BEETLES: In all cases these pests are to be directly contacted with spray to obtain adequate control. For application to upholstered furniture, provide for a thorough treatment of the interior as well as exterior of the furniture. Both the top surface and underside of rugs and carpets should be sprayed thoroughly. Shelves, closets, areas under furniture and wherever these insects are seen or suspected should be treated. When carpet beetles are a serious problem, it is recommended that an accepted residual type insecticide treatment be applied. In all cases the treatment should be repeated as necessary.

BROWN DOG TICKS: Directly contact the ticks should be made to floors, floor coverings, especially sleeping areas of animals. The area should be thoroughly treated and allowed to dry before use.

FLEAS: Liberal application should be made to floor, floor coverings, cracks, crevices, and wherever these insects may be suspected or harboring. Liberal and repeated area applications, to insure contact of all pests with the spray, are necessary for control.

BROWN DOG TICKS: Directly contact the pest with the spray. Liberal applications should be made to floors, floor coverings, bases of walls, cracks, crevices, and especially sleeping areas of animals. The bedding of the animal quarters should be thoroughly treated and allowed to dry before replacing. Repeat treatment as necessary.

STORED PRODUCT INSECTS: Control of these insects is limited to exposed stages:

For control of the above named accessible stored product insects in homes, dispose of all infested products. Shelves and drawers should be cleaned, thoroughly sprayed so as to contact all pests, and covered with shelf paper after allowing shelves to dry. Any utensils that are contacted with spray should be washed before using.

For industrial and commercial type applications, infested stored food products should be fumigated with an accepted product or to kill accessible stages of these pests, apply the product liberally. Repeat treatment as necessary.
