The amendment referred to above, submitted in connection with the Label Improvement Program Notice for Antimicrobial Products Used as Food Contact Surface Sanitizers, is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling.
 - a. On the right panel, delete the sanitization section from the label.
 - b. Delete the word "milk."
 - c. On the center panel, delete the word "sanitize."
 - d. Revise the referral statement to read:

See side panel for additional precautionary statements and Statement of Practical Treatment.
 - e. On the left side panel, delete the word "sanitization" from the label.
2. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.



DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DISINFECTION—To disinfect hard inanimate surfaces (such as walls, floors, table tops), add 2 ounces G.G. CLEANER detergent/disinfectant per gallon of water. Apply solution with mop, cloth, or sponge or mechanical sprayer so as to wet thoroughly. Allow to remain wet for 10 minutes and then let air dry.

To disinfect toilet bowls, flush toilet, add 2 ounces G.G. CLEANER detergent/disinfectant directly to the bowl water. Swab the bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

For heavily soiled areas, a pre-cleaning step is required and recommended. Prepare a fresh solution for each use.

MILDEWSTAT—To control mold and mildew on pre-cleaned, hard non-porous surfaces (such as floors, walls, table tops) add 2 ounces G.G. CLEANER per gallon of water. Apply solution with a cloth, mop, or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth reappears.

SANTIZATION—To sanitize previously cleaned and rinsed non-porous surfaces, prepare 200 ppm active quaternary G.G. CLEANER solution by adding 2 ounces to 3½ gallons of water. To sanitize immobile items (such as tanks, chopping blocks, (counter tops), flood the area with 200 ppm G.G. CLEANER solution or apply with a cloth or sponge, making sure to wet all surfaces completely for at least 60 seconds. *Rinse food contact surfaces with water.*

PRECAUTIONARY STATEMENTS—Hazard to Human and Domestic Animals

DANGER: Keep Out of Reach of Children. Causes severe eye and skin damage. Do not get in eyes, skin or on clothing. Harmful if swallowed. Wear goggles or face shield and rubber gloves when handling. Avoid contamination of food. Remove and wash contaminated clothing.

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, drink milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Call a physician.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measure against circulatory shock, respiratory depression and convulsion may be needed.
