**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Poolicide 10 is used

in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial fluid ounces of Poolicide 10 per 1,000 gallons of water. For treatment of pools with settled algae debris by cleaning. For treatment of pool add initially 41 to 75 fluid ounces of Poolicide 10 per 10,000 gallons of water. Subsequent additions of Poolicide 10 per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of Poolicide 10 per 1,000 gallons of water.

For treatment of decorative fountains should be made every 5 to 7 days after initial treatment of Poolicide 10 per 1,000 gallons of water.

Poolicide 10 is compatible with chlorine chemicals used to treat pools, spas, and decorative fountains and should be used at an alkaline pH. Poolicide 10 is compatible with decorative fountains treated with chlorine chemicals and chemicals normally required. However, do not mix Poolicide 10 with concentrated dry or liquid chlorine products.

**STORAGE AND DISPOSAL**

**STORAGE:** Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of reach of children and away from food.

**DISPOSAL:** Do not reuse empty container. Wipe out container with clear water.
