DIRECTIONS FOR LIVESTOCK PEST CONTROL

For the control of stable flies, face flies, horn flies, house flies, lice, lone star ticks on dairy cattle, beef cattle, sheep, goats or hogs. Mix 1½ to 3 gts. Ciodrin Insecticide Emulsimable Concentrate per 100 gal. of water. Spray to thoroughly cover all parts of the animal, using 2 to 4 qts. of Spray for large animals and proportionately less for smaller animals. Do not apply regularly to calves under six months of age. Brahman cattle should not be treated as they show hypersensitivity to organic phosphates.

Treatment of premises such as barn walls, eaves, fences and other breeding or resting places with above Spray will aid in reducing the fly population in the area. Repeat above applications as necessary to maintain control but no more often than once weekly.

For control of lice and winter ticks on cattle in winter hair coat, mix 11/2 pts. of Ciodrin Insecticide Emulsifiable Concentrate per 80 gallons of water. Spray animal thoroughly using 3 to 5 quarts of spray per large animal. Repeat applications as necessary to maintain control.

BACKRUBBER APPLICATIONS

For use in backrubbers or face rubbers for the control of horn flies and face flies, mix 1 gallon of Ciodrin Insecticide Emulsifiable Concentrate in 50 gallons backrubber base oil. This may be diesel fuel or a combination of diesel fuel and motor fuel in accordance with local recommendations.
