DIRECTIONS FOR USE

Local conditions may require different methods and timing of application, and the product may not be safe or effective under all conditions of intended use.

FOR USE ON LAWN AND FLOWER GARDEN SOILS: For controlling ants, chiggers, thrips and sod web worms, apply 1 lb. to 400-500 sq. ft. Lawns should be watered before application and not watered for 2-3 days afterwards. For controlling white grubs and wire worms, apply product at same rate and water immediately afterward.

Keep Children and Pets off treated areas of lawn until the product has been washed into the soil and the area is dry.

FOR USE ON VEGETABLES: Dust upper and lower surfaces in early morning or evening, when air is still. Repeat as necessary. Follow time limitations for each crop:

Controls flea beetles and green stink bugs on beans, do not apply after pods begin to form; flea beetles, Colorado potato beetle and serpentine leafminer on potatoes and tomatoes, do not apply after tomato fruits begin to form; controls imported cabbage worm, flea beetles, green stink bug and harlequin bug on cabbage, broccoli, brussel sprouts, cauliflower, kale and collards, do not apply after heads or other edible portions begin to form; controls cucumber beetle, squash bug and squash vine borer on cucumbers, melons, squash and pumpkins, do not apply after edible portions begin to form, some injury may result to certain varieties from excessive applications

FOR USE ON ORNAMENTALS: For rose chafers, leaf miners, thrips and certain other pests on roses and other ornamentals. Dust lightly but thoroughly.

FOR USE ON STRAWBERRIES: For strawberry crown borer and strawberry weevil, apply to thoroughly cover soil around the crown of the plants before bloom period or after harvest as needed.

FOR HOUSEHOLD USES (SPOT TREATMENT ONLY): Treat only those cracks and surfaces or other areas where insects have been seen resting, running or hiding, such as baseboards, electrical outlets, water pipes, heating ducts, door sills and frames, and cracks in the floor.

FOR USE ON ANTS: Thoroughly dust around door sills and window frames, along baseboards and all cracks where these pests enter the premises. Also treat entries found around water pipes, heating ducts and electrical outlets. Repeat as needed for continued control.

FOR USE ON ROACHES: Dust in cracks and other hiding and resting places of these pests in those areas around baseboards, shelving and other places of concealment. Particular attention should be made to treat all damp places such as often exist around water and sewer pipes, under plumbing fixtures, around basement drains and cracks in basement floors and walls. Repeat as needed for continued control.

FOR USE ON SILVERFISH: Treat the same as for roaches except that treatment should be concentrated on baseboards, shelving, bookcases and storage cases. Repeat as needed for continued control.

FOR USE ON BROWN DOG TICKS: Immediate treatment should be made to the baseboards, windows, door frames and floor cracks, in sleeping quarters of household pets, as well as localized areas of floors and floor coverings if necessary. Old bedding should be removed and fresh bedding provided for pets after treatment. Re-treat as reinfestation occurs. Do not apply directly to pets or other animals.

FOR USE ON CARPET BEETLES IN PREMISES: Make localized applications to floor and baseboards, treating cracks especially under carpets where these insects may be found. Baseboards, shelves and cracks in closets also should be treated. Repeat applications as needed.

CAUTION

Harmful if swallowed. Contact with skin can cause toxic symptoms. Avoid breathing of dust. In case of contact with skin, wash with soap and water. Avoid contamination of feed and foodstuffs.

Do not use this product on feed or forage to be fed to dairy animals or livestock being finished for slaughter. Do not apply or allow to drift in areas occupied by humans, beneficial animals or onto food or forage crops.

BURN CONTAINER IMMEDIATELY WHEN EMPTY. STAY OUT OF SMOKE.

Chlordane is highly toxic to fish and wildlife. Do not contaminate ornamental fish ponds with this product. To protect bees, do not apply when crops are in bloom. Remove or cover hives if dusting is necessary.

NOTE: Birds feeding over treated lawns may be harmed.
