SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT.
APPLY IN SHORT BURSTS.

To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before reentry. Sweep up and throw away fallen insects.

To Kill Cockroaches, Ants and Crickets: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window fames, ant trails and other areas of entry. Repeat as necessary.

STORAGE: Store in a cool dry area (preferably locked) inaccessible to children and pets and away from heat, open flame or other sources of heat or ignition. DISPOSAL: Replace cap, wrap container and put in trash collection. Do not incinerate or puncture.
