

When applied as directed to precleaned hard, non-porous surfaces, this disinfectant also kills the following organisms at 1 ounce per gallon: *Candida albicans*, *Escherichia coli*, *Streptococcus pyogenes*, *Enterobacter aerogenes*, *Shigella sonnei*.

PRACTICAL TREATMENT (FIRST AID): In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician.
