Dear Mr. Baker:

The labeling revisions referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, are acceptable provided that you make the labeling changes indicated below before you release the products for shipment bearing the amended labels:

1. In each of the above three labels change the wording under the heading "Animal" from the present age of 4 weeks to 12 weeks for treatment of puppies or kittens.

2. In the Adams Flea & Tick Dust II label change the wording in the center of the label just above the Active Ingredients listing to "FOR DOGS*PUPPIES*CATS*KITTENS** Over 12 Weeks of Age".

Submit two copies of your final printed labeling for each of the above products before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the above three labels is enclosed for your records.

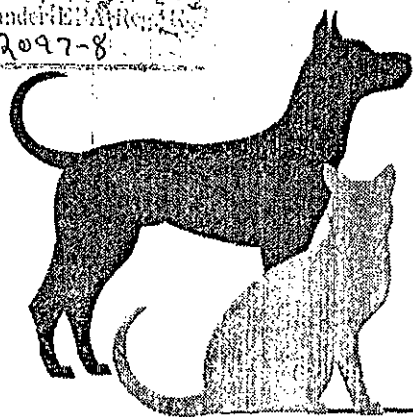

Storage: Store in a cool, dry area.

Disposal: Do not reuse container. Rinse thoroughly and wrap container in several layers of newspaper and discard in trash.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

USER SAFETY REQUIREMENTS

- Wear long-sleeved shirt, long pants, shoes plus socks and household latex or rubber gloves when applying this product.
- Change clothing as soon as possible after use.
- Wash the outside of gloves before removing. As with any pesticide product, wash hands thoroughly immediately after handling and before eating, smoking or using the toilet.

Use product only outside or in a well-ventilated area. Wear household latex or rubber gloves.

This product should not be applied by children.

As a precaution, a bland ophthalmic ointment should be placed in the eyes prior to bathing to prevent possible irritation.

Thoroughly soak animal with warm water taking 2-3 minutes to wet hair. Apply Mycodex Pet Shampoo with Carbaryl on head and ears and lather, then repeat procedure with neck, chest, middle, and hindquarters, finishing legs last. For best effects, allow lather to remain in contact with skin for 5 minutes before rinsing. Rinse thoroughly. Use no more than once weekly. Do not allow to get into eyes or on scrotum. For a complete flea and tick control program consult your veterinarian.
