DIRECTIONS FOR USE

Apply dust directly from can by punching out holes in top; or apply with a hand duster.

ANTS

In Lawns. Apply directly to anthills. Water thoroughly to get material down into nests. Also apply to ant-trails and places where ants are known to frequent.

For Flawers and Ornamentals. Apply on soil only around base of plants.

LAWN INSECTS

To control ants, chiggers, mole crickets, ticks, apply at rate of 1 pound per 1,000 square feet. Water material down into soil thoroughly.

SOIL INSECTS

Lawns. To control white grubs apply at rate of 1 pound per 800 square feet. For Japanese beetle grubs use 1 pound per 500 square feet. Water thoroughly after application to get material down into soil. To control **Spd Webworm** (Lawn Moth) use 1 pound per 800 square feet; water lawn thoroughly before application and do not water again for several days. Remains effective entire season.

Gardens. Apply to soil before planting, or at planting or transplanting time only. Do not contaminate edible parts. Apply at rate of 1 pound per 1,000 square feet and work into top 2 or 3 inches of soil around base of plants. Controls: Asiatic garden beetle grubs, cutworms, Japanese beetle grubs, white-fringed beetle grubs, white grubs, wireworms on beans, beets, cabbage and

EARWIGS

Apply to infested areas at rate of 1 pound per 1,000 square feet. Apply around fences, house foundations, and refuse, trash and compost piles. Also treat lawns.
