Dormant Season:





DIRECTIONS

- 1. Stir contents to even consistency.
- 2. For the Growing Season, use 1 gallon of Z.I.P. to 25 gallons of water or 1 pint to 3 gallons of water and apply as new growth appears.
- 3. For Dormant Season spraying, use 1 gallon of Z.I.P. to 3 gallons of water.
- 4. Use low pressure for spraying; 150# per square inch or less. A penetrating spray is usually not necessary.
- 5. Apply thoroughly to the portions of the plants that can be reached by the deer and robbits.
- 6. Additional wetting agents are not necessary.
- 7. Protect the contents of the container from drying and freezing.
