

### GENERAL INFORMATION

DRINOX H-34B, when used as directed, will help protect seeds and seedlings of wheat, barley, oats, corn, sorghum and cotton, from wireworms and seed-corn maggots. DRINOX H-34B, when used as directed, will help protect corn against attack from seed-corn beetles and Southern corn rootworms. It will also help to protect barley, oats and wheat from attack by false wireworms, and sorghum from attack by Kafir ants.

### CAUTION

This product is toxic to fish and wildlife. Keep out of any body of water. Treated seeds exposed on soil surface will be hazardous to birds and other wildlife. Do not re-use empty drum. Destroy by perforating or crushing and burying in non-crop lands away from water supplies.

### PRECAUTIONS

KEEP AWAY FROM HEAT AND OPEN FIRE. Flash point above 90° F. The crystals that may form at extremely low temperatures should disappear after the temperature of the liquid is increased and the container well shaken.
