BETANEX is a selective post-emergence herbicide for use in sugar beets for control of the following weeds:

Spray Kochia while in the rosette stage, less than 1" in diameter.

For best results, spray when the weeds are at the twoleaf stage.

## **USE PRECAUTIONS**

MAKE ONLY ONE APPLICATION OF BETANEX DURING EACH GROWING SEASON.

DO NOT APPLY BETANEX OR THE BETANEX -BETANAL TANK-MIX TO SUGAR BEETS LATER THAN 90 DAYS PRIOR TO HARVEST.


Perforate empty containers and dispose of left-over spray solution and concentrate by burying in non-cropland away from water supplies
