AS A SPACE SPRAY: Use 2% owners of this product as a finely dividing floating apray or fog for each 1,000 cubic feet of space. Open all cupboards, closets and lockers. An exposure for one hour will give a high degree of control, but for maximum results allow room to be closed for 4 to 8 hours. Cover all foodstuffs to avoid contamination from falling insects. Repeat as often as necessary.

ROACHES, WATER BUGS, SILVERFISH: This can be used as a coarse spray so that it will not float in the air. Direct spray to surfaces of cupboards, lockers and other places where insects hide. Spray all cracks, crevices and other hiding places, and wherever else insects hide. Spray all cracks, crevices and other hiding places, and wherever else these insects have been noticed. The specified insects hit by the spray will be killed quickly. Apply at the rate of one ounce to about six square feet of surface as often as necessary.

ANTS: For best requits spray ant trails.
