DIRECTIONS

To control most weeds and grasses for extended periods on non-cropland areas such as industrial, lant sites, parking lots, loading ramps and around storage buildings and similar non-crop areas, apply 1 to 4 gallons per 1,000 square feet of WEED KILLER WITH SURE-AIM after the most predominant weeds have emerged. No agitation is required. This weed killer can be applied with standard spray equipment. For treating small areas a tank type hand sprayer or sprinkler can be used.

NOTE: Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of this weed killer in their particular area.

IMPORTANT: Do not apply directly to, or otherwise permit this weed killer to contact desirable, woody or herbaceous plants. Do not apply to areas underlaid by roots of trees and shrubs. Avoid spray drift to such plants (coarse sprays are less likely to drift). Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use same equipment for other purposes). Do not store near fertilizers, seeds, insecticides or fungicides. Do not re-use this container. Rinse, puncture and discard.

This weed killer is toxic to fish and wildlife. Do not contaminate any body of water.

Do not apply where weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.
