Ants, Brown Dog Ticks, Clover Mites, Crickets, Earwigs, Fleas, Flies, Millipedes, Mosquitoes, Roaches, Scorpions, Silverfish, Sowbugs, Spiders.

In addition to rapid kill the solution stays on the treated surfaces and gives long residual activity.

It is designed for use in food processing plants, warehouses, restaurants, motels, institutions and industrial plants.

HOW TO USE

This insecticide is ready to use undiluted as it comes from the can, and may be applied with either power operated or hand sprayers. Apply a coarse spray to infested surfaces until wet, moving the spray stream rapidly enough to prevent excessive wetting of surfaces and waste of material. Direct spray away from people, plants, and pets. Do not re-use empty container. Puncture and discard.

RESTRICTIONS

Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings. Do not allow the small, finger-operated, plastic attachment type sprayer to remain in solution for extended periods as the plastic sprayer may be damaged.

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

INDOOR USE

Ants, Cockroaches, Crickets, Silverfish, Spiders, Scorpions, Waterbugs: Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. For ants, spray trails and places where ants enter premises. Repeat as needed. Do not spray foodstuffs or house plants. Remove pets and cover fish bowls before spraying. Do not allow children to contact the treated areas until surfaces are thoroughly dry.

Brown Dog Ticks: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floor. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

OUTDOOR USE

Ants, Clover Mites, Crickets, Earwigs, Fleas, Flies, Mosquitoes, Millipedes, Sowbugs and Brown Dog Ticks: Spray infested areas thoroughly, including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

CAUTION

FLAMMABLE- Do not spray into or near open flame. Do not smoke while using. Keep container away from stoves, radiators, and all other hot surfaces.

May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes or clothing should also be avoided. Wash thoroughly after using. Avoid contamination of food, utensils, and food preparation areas.

Should illness occur, get prompt medical aid.

To physician - Atropine Sulfate is antidotal.

Do not re-use container. Puncture and discard, preferably by burying.
