#### DIRECTIONS FOR USE

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

##### Sod Webworms, etc. 10,000 sq. ft. Rate

To control chinch bugs, sod webworms, ants, armyworms, brown dog ticks, crickets, cutworms, earwigs, fleas, and sowbugs, uniformly apply the contents of this 20 lb. bag to cover 10,000 sq. ft. of noncrop turf grass area using any hand or power-operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear; re-treat as needed. To help obtain uniform distribution, apply one-half the required amount of product in one direction; then apply the balance at a right angle. Immediately after application, thoroughly water the treated turf to wash the insecticide into the zone of insect infestation.

##### White Grubs, 5,000 sq. ft. Rate

To control certain white grubs (larvae of European chafer and Japanese beetle) use 10 to 20 pounds of this product per 2,500 sq. ft. Apply the granules uniformly over the area treated followed immediately by thorough watering to wash the insecticide into the turf. For best results treat when grubs are young and actively feeding near the soil surface, usually during late July and August.

To control Hyperodes (turfgrass) weevils uniformly apply 20 pounds of granules per 5,000 sq. ft. as directed above. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialist for best time to treat in your area.

#### DIRECTIONS FOR FERTILIZATION

When used as directed for sod webworms (20 lbs. per 10,000 sq. ft.) Dursban® Plus will supply .6 lbs. of nitrogen per 1,000 sq. ft. of turf and 1.2 lbs. nitrogen at the white grub control rate, water in for grubs.
