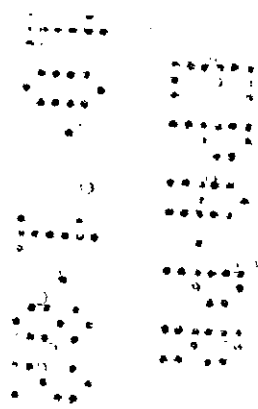

Pesticide or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or local procedures.

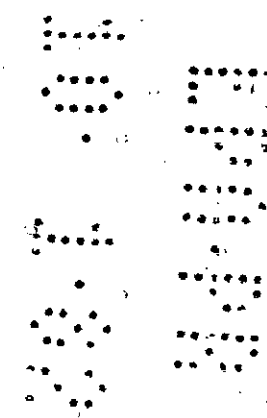
Container Disposal
