The amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Response to Agency letter dated August 22, 2002

Conditions

Revise the label as follows:

- 1. The heading, "Storage," for the containers greater than one gallon must be in bold and capitalized to correspond with the "Container Disposal" and "Pesticide Disposal" headings.
- 2. The heading, "Cleaning/Deodorization," must be placed in bold for consistency with the other directions.
- 3. Since this product may be used in barber shops/beauty salon utensils, the label must have appropriate directions. You must add the following language to the label for this use or delete the use.

Barber (Salon) Instruments and Tools Disinfection: Precleaning is required for heavily soiled instruments and tools. To disinfect hard, nonporous instruments and tools mix 1 oz. to 1 gallon of water. Completely immerse combs, brushes, rollers, razors, scissors, blades, manicure and other salon instruments and tools for 10 minutes. Rinse thoroughly and dry before use. Prepare a fresh solution daily or more often if the solution becomes visibly diluted, cloudy, or soiled.

Note: Plastics may remain immersed until ready to use. Stainless steel shears and instruments must be removed after 10 minutes, rinsed, dried, and kept in a clean, noncontaminated receptacle. Prolonged soaking may cause damage to metal instruments.

A stamped copy of the labeling accepted with conditions is enclosed. Submit three (3) copies of your final printed label before distributing or selling the product bearing the revised labeling.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. May cause irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Clean/Deodorization: To clear and decdorize hards non porous surfaces prepare a use solution of 1 oz of product per gallon of water. Using a mop, sponge, or cloth, wet surfaces and allow to air the

General Disinfection: Pre-cleaning is required for heavily soiled areas. To disinfect hard non-porous surfaces such as walls, floors, Mix 1 oz to 1 gallon of water, apply use softtien with sponge, cloth or mop as to thoroughly wer surfaces. Let stand for 10 minutes and allow to air dry. Change use solution daily or as it becomes visibly dirty/soiled.
