
Revise the label as follows:

The "Disposal of Infectious Material" statement under the HIV directions must be brought Into compliance with PR Notice 2000-5, Mandatory Labeling, by deleting the term, should, and stating "must."

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. May cause irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

ELIMSTAPH # 2 is a hospital use disinfectant at 1:128 dilution (1 oz per gallon). Bactericidal according to the current AOAC Use-Dilution Test Method and Virucidal* according to the virucidal qualification modified in the presence of 400 ppm hard water plus

ELIMSTAPH # 2 may be used on any washable HARD NONPORUS SURFACES including, appliance exteriors, bathtubs. sinks and shower stalls (including fiberglass), bathroom fixtures, conductive flooring, counters (countertops & laminates), garbage cans, stovetops, telephones, and walls. ELIMSTAPH # 2 may also be used on glazed tile, Formica, glazed ceramic, glazed porcelain, laminated surfaces, metal, plastics, stainless steel, vinyl/plastic upholstery, finished woodwork.

Cleaning/Deodorization: To clean and deodorize washable hard, non porous surfaces prepare a use solution of 1 oz of product per gallon of water. Using a mop, sponge, or cloth, wet surfaces and allow to air dry. General Disinfection: Pre-cleaning is required for heavily soiled areas. To disinfect hard non-porous surfaces such as walls, floors, Mix 1 oz to 1 gallon of water, apply use solution with sponge, cloth or mop as to thoroughly wet surfaces. Let stand for 10 minutes and allow to air dry. Change use solution daily or as it becomes visibly dirty/soiled. Barber (Salon) Instruments and Tools Disinfection: Precleaning is required for heavily soiled instuments and tools. To disinfect hard, non porous instruments and tools mix 1 oz. to 1 gallon of water. Completely immerse combs, brushes, rollers, razors, scissors, blades, manicure and other salon instruments and tools for 10 minutes. Rinse thoroughly and dry before use. Prepare a fresh solution daily or more often if the solution becomes visibly diluted, cloudy, or soiled.

Note: Plastics may remain immersed until ready to use. Stainless steel shears and instruments must be removed after 10 minutes, rinsed, dried, and kept in a clean, non contaminated receptacle. Prolonged soaking may cause damage to metal instruments.

Disinfection of Personal Safety Equipment: To disinfect personal safety equipment such as hard hats, face shields, goggles, spectacles, protective headgear, hearing protectors, gas masks, and self-contained breathing apparatus (SCBA), Mix 1 oz to 1 gallon of water, apply use solution by immersion or with sponge or cloth as to thoroughly wet surfaces. Let stand for 10 minutes then thoroughly rinse equipment with clean water. Allow to air dry before reuse. Change use solution daily or as it becomes visibly dirty/soiled. Use product in conjunction with the use instructions provided with the safety equipment to avoid damage.

*VIRUCIDAL PERFORMANCE

At 1 oz. per gallon use level, ELIMSTAPH NO. 2 was evaluated in the presence of 5% serum and 400 ppm hard water for a contact time of 10 minutes at room temperature (20-25°C) against HIV-1 (AIDS VIRUS) found on inanimate, hard, non-porous environmental surfaces.

*Kills HIV on pre-cleaned environmental surfaces/objects previously soiled with blood/body fluids in health care settings or other settings in which there is an expected likelihood of soiling of inanimate surfaces/ objects with blood or body fluids and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of human immunodeficiency virus Type 1 (HIV-1) (associated with AIDS).

SPECIAL INSTRUCTIONS FOR CLEANING AND **DECONTAMINATION AGAINST HIV-1 ON SURFACES/OBJECTS** SOILED WITH BLOOD/BODY FLUIDS"

Personal Protection: Clean-up should always be done wearing protective latex gloves, gowns, masks and eve protection.

Cleaning Procedure: Blood and other body fluids containing HIV must be thoroughly cleaned from surfaces and objects before application of ELIMSTAPH NO.2.

Contact Time: Leave surface wet for 10 minutes with 1 oz. per gallon use

Disposal of Infectious Material: Blood, body fluids, cleaning materials. and clothing should be autoclaved and disposed of according to local regulations for infectious waste disposal.

At 1 oz per gallon use level ELIMSTAPH # 2 eliminates static electricity on surfaces not affected by water. Lightly spray the area where you want to control static electricity and let air dry.
