PYRAID-20 CONCENTRATE is an economical and effective insecticide for use around outdoor pool, patio and Bar-B-Que areas; barns, stable and milking parlors; outdoor motel and hotel areas. It is designed to kill ants, fleas, roaches, waterbugs, silverfish, bedbugs, house flies, mosquitoes, gnats, clothes moths, small flying moths, stable flies, horse flies, horn flies, deer flies.

CAUTION: Keep out of reach of children.

Remove pets, birds and cover fish aquariums before spraying. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation.

DIRECTIONS FOR USE.

Pour the contents of this can into 30 gallon tank. Add 25 gallons of water under normal hose pressure to thoroughly mixed insecticide. PYRAID-20 CONCENTRATE, when mixed thoroughly with water, forms a stable emulsion.

FOR ROACHES, WATERBUGS, SILVERFISH: Spray directly at insects and into all crevices, cracks and other hiding places. Continue spraying until all insects and hiding places have been hit. Leave room closed for 20 minutes. Do not remain in treated areas. Ventilate the area after treatment is completed. Repeat as often as necessary.

FOR HOUSE FLIES, MOSQUITOES, GNATS, SMALL FLYING MOTHS: Close up infested area [room] and fill with mist, using an upward sweeping motion. Then spray ceilings, walls, screens, window frames and other areas where pests may alight or congregate. Leave space closed for 10 to 15 minutes after treatment. Sweep up and destroy fallen insects at the close of the 10 to 15 minute period. Do not remain in treated areas. Ventilate the area after treatment is completed.

FOR HORSE FLIES, HORN FLIES, STABLE FLIES, DEER FLIES: In addition to procedure used for house flies, dairy barns, milkrooms, stables and other sleeping quarters of animal, norses: horse flies, stable flies; cattle: horn flies, stable flies). When treating for horn flies and house flies, apply a light mist sufficient to wet the tips of the hair. For stable flies, horse flies, deer flies, apply 2 ounces per animal sufficient to wet hair but not to soak the hide. Repeat as necessary.

FOR ANTS: Follow procedure for roaches and spray ants, trails and areas around door sills and window frames. Repeat as often as necessary.

FOR CLOTHES MOTHS: Clean, air and brush clothing and fabrics. Spray clothing and fabrics, particularly seams, pleats and folds (do not soak),

holding sprayer three feet away. Repeat every thirty days unless clothes are stored in mothtight containers. Spray empty closets. [Test for discoloration before spraying.]

FOR BEDBUGS: Spray bed and mattress thoroughly. Direct spray into all cracks and hiding places about bedroom, baseboards, walls, floors. Contact as many pests as possible. Repeat as necessary.

FOR FLEAS: Same as roaches plus additional treatment of floors, wall cracks, baseboards, floor coverings, sleeping quarters of animals [dogs and cats]. Contact as many pests as possible. Repeat as necessary.

OUTDOOR AREAS: Spray all gnats, mosquitoes and flies in outdoor areas (outdoor pool, patio, Bar-B-Que areas, outdoor motels and hotels) with an upward sweeping motion for approximately 10 seconds. Mist spray applications can be applied for temporary control of small populations of pests in tall grass, shrubbery and around lawns where these pests may hover or rest. This usage is suitable in still air and requires frequent reapplication to kill additional insects that may be drifting into the area. Do not wet foliage.

ENVIRONMENTAL CAUTIONS: This product is toxic to fish. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
