

TERMITES—Add ½ quart to 12 gallons of water. Apply 2 gallons per 5 linear feet in trenches around the foundation of buildings to the depth of the foundation and not below the top of the footing, or 4 gallons per linear foot when trenches are deeper than 18 inches. If trench is deeper than 18 inches, one gallon of the solution should be applied per each linear foot of trench. Half of the amount should be applied to the bottom of the trench with the remainder being applied to the backfill. Apply 1 gallon per 10 square feet as an overall treatment under the slab and under attached porches. Treat thoroughly any wood coming in contact with soil. Replace damaged wood and treat new wood by painting a surface with same solution. The objective is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment. It is suggested that you consult the State Extension Service for advice.
