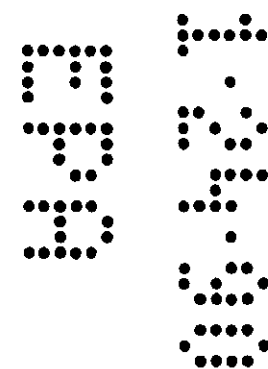

AS A MIST: Spray once daily at milking time, using 1 to 2 ounces per head, applied as a light mist. May be used twice daily at the rate of 1 oz. per animal. Avoid wetting the hides of animals.

AS A SPACE SPRAY: As a space spray for flies, gnats and mosquitoes, spray at the rate of 2 ounces per 1000 cubic feet and keep all windows and doors closed for 15 minutes after spraying. Cover or remove all milk and milk equipment before spraying. Vacate treated areas and ventilate before re-occupying.
