

ANIMAL BUILDINGS—Apply Vapona Insecticide 25-E as a 0.5% spray to control flies, gnats, mosquitoes, roaches, fleas, ants, sowbugs, and brown dog ticks.

To prepare a 0.5% spray, dilute one pint of Vapona Insecticide 25-E \*h 6 gallons of water. Apply as a coarse, wet spray at the rate of quart per 1000 square feet.




