NOTIFICATION: Minor revisions to Directions for Use per Pesticide Registration Notice (PRN) 98-10:

- Specific storage instructions are not presented in the Label Review Manual for DDVP, and **we ask to omit one (1) statement presented in the Storage section of the labeling:** "To prevent cross-contamination, keep separate from other pesticides, fertilizers, seeds, food and feed."

Two (2) reasons are listed as follows:

1. DDVP is limited in agricultural uses, and this formulation containing 1.0% DDVP is intended for direct applications to livestock and for animal premise treatments. Since 1995, AMVAC has deleted uses/sites including food service establishments and food processing establishments. Other use patterns/sites have not been supported, and we believe that the reference to "food" may result in misuse.
2. To reduce the possibility of accidental poisonings, our labeling includes this prohibition and this precaution: "Do not contaminate water, food or feed by storage or disposal. Store in original container in a locked storage area inaccessible to children or pets." Proper storage ensures human safety and these precautions are focused primarily for the users. However, distributors, wholesalers and certain retailers have misinterpreted the meaning of "To prevent cross-contamination, keep separate from other pesticides, fertilizers, seeds, food and feed." for warehouse storage. Exposure to DDVP in sealed containers in a warehouse would be expected to be negligible.

One (1) copy of the annotated labeling is enclosed for your review.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or Confidential Statement of Formula of this product. I understand that it is a violation of 18 U.S.C Sec. 1001 to willfully make any false statement to the EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under Section 12 and 14 of FIFRA.



ANIMAL BUILDINGS, INCLUDING BARNs, FEEDING AREAS, SHELTERS, STABLES, AND DAIRY BARNs:

House Flies in Dog Kennels, Hog Pens, Stables, Compost Areas, Manure, Poultry Houses, and Barns - Application of this product should be as a coarse spray. Apply thoroughly to walls, flooring in kennels, barns, and stables. Use no more than 1 pint of product per 1,000 square feet. This is not a residual spray, therefore treat weekly or as needed for control of flies and fleas.

DIRECT ANIMAL TREATMENTS FOR DAIRY AND BEEF CATTLE

FACE FLY - STABLE FLY - HORN FLY - MOSQUITOES:

Use a hand mist sprayer and treat entire animal with 1 fluid ounce of product to wet hair in morning and evening. For Horn Flies, especially treat the back line, withers and belly. For Stable Flies, make sure to spray leg areas and particularly ankles. Repeat daily as needed for control. Do not apply more than 2 fluid ounces of product per animal daily. Special care should be used in spraying the legs, belly and shoulders. Wash the teats and udder with warm water prior to milking. Do not apply to sick or convalescing animals. For walk-thru mist sprayers, set to treat animals at rate not to exceed 2 fluid ounces daily.

IMPORTANT: Avoid wetting the hides of animals. Do not apply to calves under 6 months of age. Brahman cattle and Brahman cattle crosses should not be treated as they may show hypersensitivity to organophosphate insecticides. Do not apply dermally in conjunction with Trichlorfon and do not use on animals simultaneously or within a few days before or after treatment with, or exposure to, cholinesterase inhibiting drugs, pesticides or chemicals. Do not allow spray mist to contaminate milk or milking utensils. Cover feed and feed troughs before spraying.

Equivalent Measures: 1 fluid ounce = 2 tablespoons = 6 teaspoons

OVERHEAD MIST DISPENSERS IN ANIMAL BUILDINGS AND DAIRY MILK ROOM

For control of flies, gnats, and mosquitoes in milkhouses and barns, use 1 pint of product for each 8,000 cubic feet. If a program of spraying animals directly is employed daily, do not fog within 8 hours of direct applications.

Remove the animals before fogging. Applicator must not remain in treated area. Before applying reduce air movement as much as possible by closing doors, windows and other openings. Do not contaminate water, feed or foodstuffs, milk or milking utensils.
