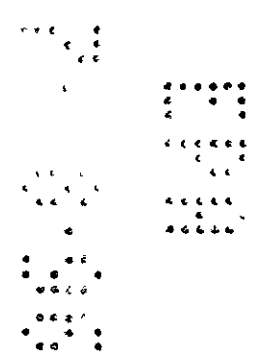

For use on residential and other turf sites excluding sodfarms.

STORAGE: Store in original container in a locked storage area inaccessible to children or pets.

PESTICIDE DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.

USE PRECAUTIONS: Do not apply or allow the granules to contact susceptible plants such as tomatoes, roses, flowering plants, grapes, fruit trees or other desirable plants. Do not apply to newly seeded turf areas or creeping grasses such as Bent. Do not contaminate irrigation ditches or water used for domestic purposes or for spraying. Do not use for other purposes than shown on this label. Do not contaminate lakes or ponds where water is used for spraying. - FOR LAWNS AND TURF -

Punch holes in lid. For spot treatment, apply directly to weeds. A second treatment one month later may be needed to control those weeds that did not receive application. Kills dandelions, plantain, shepherdspurse, ragweed, dock, henbit, lambsquarters, pennywort, and dog fennel. Do not overdose since injury to turf may result. Treatment should be kept three feet from desirable plants. Do not treat spring seeded lawns until after second cutting. Weeds over 6 inches high should be sprayed using our "Lawn Weed Killer" spray. Do not use on St. Augustinegrass. Weed killing effect is shown within 10 days and plants will be dead within 20 to 25 days. Possible injury may occur to clover lawns.

~~FOR WATER WEEDS~~

~~Use only in ponds and lakes where water is still. Spread evenly over ice or water surface in late winter or early spring at the rate of 1 pound per 430 square feet, or 100 pounds per acre. Weed kill is accomplished through roots of water weeds since granules settle to the bottom. Reaction is slow but effect is seen 4 to 8 weeks after granules reach bottom with an expected control up to 1½ years. Retreat as new weeds appear. This application will kill water lilies, milfoil, pondweed, fanwort, cattails, spatterdock and arrowhead. Do not use this product in irrigation water. If weed infestation is heavy, do not treat entire body of water at one time since the decaying vegetation may deplete the oxygen supply, thus suffocating the fish. Treat other portions of water in 2 to 3 months. Treat only 1/3 to 1/2 of the water area in a single operation.~~
