WHEN TO USE: Spray at any time during the growing season when weeds are actively growing. Treat chickweed, henbit, wild onion and gartic in the fall and again in the spring if needed. On new grass lawns wait until the turf has reached a height of 2 inches before making an overall spray treatment. Spot spray treatments may be made at any time with a small pressure sprayer spraying only the weeds at ground level. Wait 2 weeks before seeding or planting stolons, plugs or sprigs. Do not spray weeds during drought periods unless the lawn has been thoroughly watered 2-3 days before.

Do not allow spray to get on vegetables or ornamental plants since injury may result. Do not use on centipedegrass or St. Augustinegrass or on lawns or turf where desirable bentgrass or clovers are present.
