PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animal

WHERE TO USE:

May be used on bluegrass, Bermuda and Zoysia lawns, vacant lots, playgrounds and other similar areas where HARD-TO-KILL weeds are present. Effective against these weeds such as SHEEP SORREL, KNOTWEED, SPOTTED SPURGE, CHICKWEED, OXALIS and HENBIT.

It is not necessary to increase the dose for these hard-to-kill weeds.

WHEN TO USE:

Spray at any time during the growing season when weeds are actively growing. Treat Chickweed, Henbit, Wild Onion and Garlic in the fall and again in the spring if needed. On new grass lawns wait until the turf has reached a height of 2 inches before making an overall spray treatment. Spot spray weed treatment, however, may be made at any time with a small pressure sprayer spraying only the weeds at ground level. Wait 2 weeks before putting new grass seed or stolens down in the bare spots. Do not spray weeds during drought periods unless the lawn has been thoroughly watered 2-3 days before.

TO SPRAY ENTIRE LAWN

[#]For Lawn Hose Sprayers dilute the amount shown above with enough water to fill the sprayer bottle to the 2 gal. level for 330 sq. ft. — to the 6 gal. level for 1320 sq.ft. — to the 12 gal. level for 2640 sq. ft.

TO SPOT-SPRAY WEEDS

Lawn Hose Sprayers are not suited for this type of treatment. Use a pressure sprayer. Mix 8 oz. of this product in 3 gals of water and spray each weed to point of spray run-off.

For best results use a spreader sticker when making application.
