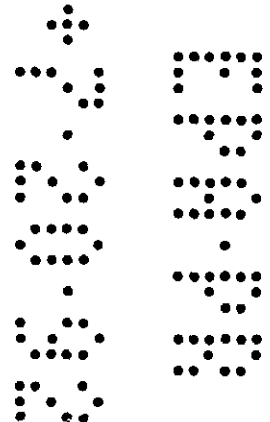

Hazards to Humans & Domestic Animals

Statement of Practical Treatment

IF SWALLOWED: Call a physician immediately. Gastric lavage is not indicated if material was taken internally. **DO NOT INDUCE VOMITING** unless other treatment is not available. Vomiting may cause aspiration pneumonia. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply respiration if indicated.

IF ON SKIN: Wash contaminated skin with soap and water.

IF IN EYES: Flush eyes with plenty of water for at least 15 minutes. Get medical attention.

STORAGE & DISPOSAL

STORAGE: Store in original container in a locked storage area inaccessible to children or pets. To prevent cross-contamination during storage, keep separate from other pesticides, fertilizers, seeds, food, and feed.

PESTICIDE DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.

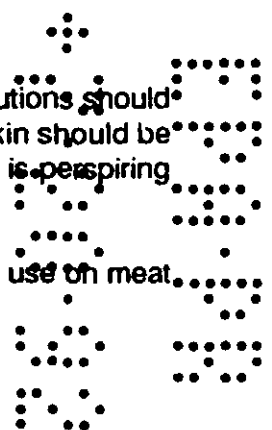
- USE DIRECTIONS -

The objective is to create a barrier on the hair that will both repel and kill biting flies. Precautions should be taken to avoid any wetting of the animal's skin. Any direct contact with the animal's skin should be avoided, particularly when skin pores are open, such as after exercise or when the animal is perspiring heavily. Extra care should be taken with thin-haired or thin-skinned animals.

Do not contaminate feed or feeding utensils. Cover or remove feed before spraying. Do not use on meat or dairy animals. Do not wet the animal's skin.

APPLY THIS PRODUCT ONLY AS SPECIFIED ON THIS LABEL

GENERAL: Horse & Pony Spray is formulated for use on horse and pony show stock. Horse & Pony Spray protects against biting flies and will impart a bright sheen to your animal's coat. Horse & Pony Spray may be misted or wiped on. Use no more than 1 or 2 fluid ounces per animal per application.



AS A MIST: Select a hand-sprayer that will deliver a mist. Set the sprayer to the "Fine Mist" position. Do not use coarse sprays. Do not wet the animal's skin. A gentle fine mist is all that is required. Do not make applications in direct or hot sunlight. Do not use on meat or dairy animals. Apply 1-2 fluid ounces or 2-4 tablespoons per animal to ears, legs, belly, neck, and back (except under saddles). After application, brush the coat to give overall coverage. Make sure legs and ankles are treated. For face area, treat as a wipe-on application. For deer flies and horse flies, apply at 3 day intervals. For house flies and stable flies, apply at 7 day intervals. For gnats, horn flies, and mosquitoes, apply at 14 day intervals. Also, spray adjacent stable areas for more effective fly control. Cover securely feedstuffs, troughs, bins, or other food and water receptacles while spraying.

TO WIPE-ON: Do not wet the animal's skin. Rub the animal down and remove dirt. Mist 1 fluid ounce per animal or 2 tablespoons per animal into a soft cloth and wipe on against the hair grain. Make sure to treat ears, legs, belly, neck, face and back (except under saddles). Afterward, brush the coat to bring out a bright sheen. For deer flies and horse flies, apply at 3 day intervals. For house flies and stable flies, apply at 7 day intervals. For gnats, horn flies, and mosquitoes, apply at 14 day intervals.

NOTE: Use no more than 1 or 2 fluid ounces of product per animal per application. As a mist, set your sprayer to the "Fine Mist" position only and brush across the coat to achieve overall coverage. As a wipe-on, lightly mist a small amount onto a soft cloth and wipe against the hair grain. Brushing afterward will bring out a bright sheen to the animal's coat.
