### **HOW TO APPLY:**

[Gordon's Horse and Pony Spray][This product] protects against biting flies and will impart a bright sheen to your animal's coat.

[Gordon's Horse and Pony Spray] [This product]will provide short-term protection (3 to 14 days) depending upon the fly species.

[Gordon's Horse and Pony Spray] [This product] may be applied as a fine mist with a sprayer or wiped on with a soft cloth. Read the entire label before application and refer to the chart for spray intervals and instructions.

### **TO PREVENT INJURY APPLY THIS PRODUCT ONLY AS SPECIFIED ON THIS LABEL. DO NOT WET THE ANIMAL'S SKIN.**

The objective is to create a barrier on the hair that will both repel and kill biting flies. The product is intended as a preventative measure and is not intended to help an animal recover from existing sores, skin lesions or bites due to pests. If the animal has open sores, skin lesions, cuts, wounds, or irritated skin from pest infestations contact your veterinarian before using this product.

Avoid any direct contact between the product and the animal's skin, particularly when skin pores are open, such as after exercise or when the animal is perspiring heavily. Use extra care with young, old or sick animals. Also, use extra care with thin haired or light skinned animals such as Arabians and Palominos. Do not allow product to contact animal's eyes, nose, mouth, or sores during application.

### **USE RESTRICTIONS:**

Do not contaminate feed or feeding utensils. Cover or remove feed before spraying. Do not use on foals under 6 weeks old. Not for use on meat or dairy animals, poultry, horses or foals intended for slaughter or human consumption.

Do not apply more than 6.5 fl.oz. of product per application per animal [0.036 lb of butoxypolypropylene glycol per application per animal]. Do not apply more than 1 time per day. Do not apply within one day. Do not apply microencapsulated product to lactating or food animals.

Not for use in farm structures or buildings housing food producing animals or poultry, or in milk rooms. Do not apply this product with a sponge. This product is intended for indoor use only. Not for use in outdoor residential misting systems. Only spray in a well ventilated area. Do not spray product when food is present.

**APPLICATION METHOD:**

**Mist:**

- Ready-To-Use: Use undiluted as a localized or spot treatment applied with mist/trigger sprayers.
- Apply this product to a clean coat. Brush animal to remove loose dust and dirt.
- Apply 3.25 to 6.5 fl.oz. of product per application per animal. Apply directly to face, neck, shoulders, flanks, back, legs and areas described in Table 1. Select the lower volume of product for low infestations and lower animal (horse) body weights.
- For initial treatments, apply daily for 2 or 3 days. As infestations decline, repeat the application at 14 to 21 day intervals if needed, if infestation persists, or if prescribed by veterinarian. The duration of activity may vary because of environmental conditions (e.g. rainfall) and management factors (husbandry, bathing or shampooing).
- Set the sprayer to the “Fine Mist” position; do not use coarse sprays. Do not make application in direct, hot sunlight.
- Do not wet the animal’s skin.
- Do not apply to areas where animal has no hair. Avoid direct contact with the animal’s skin.
- After application, brush the coat for uniform coverage. Securely cover feedstuffs, troughs, bins, or other food and water receptacles while spraying.

**Wipe-On:**

- Ready-To-Use: Use undiluted as a localized or spot treatment as a wipe-on with an applicator mitt, or clean towel.
- Ready-To-Use: Use undiluted as a localized or spot treatment as a wipe-on with a towelette or other impregnated material.
- Apply this product to a clean coat. Brush animal to remove loose dust and dirt.
- Apply 3.25 to 6.5 fl.oz. of product per application per animal. Apply directly to face, neck, shoulders, flanks, back, legs, and areas described in Table 1. Select the lower volume of product for low infestations and lower animal (horse) body weights.
- For initial treatments, apply daily for 2 or 3 days. As infestations decline, repeat the application at 14 to 21 day intervals if needed, if infestation persists, or if prescribed by veterinarian. The duration of activity may vary because of environmental conditions (e.g. rainfall) and management factors (husbandry, bathing or shampooing).
- Do not wet the animal’s skin.
- Do not apply to areas where animal has no hair. Avoid direct contact with the animal’s skin.
- Securely cover feedstuffs, troughs, bins, or other food and water receptacles while spraying.

<b>Ready-To-Use</b> Use undiluted as a localized or spot treatment.	Horse flies or deer flies	3.25 to 6.5 fl.oz. per application	14 to 21 days	Apply to head, neck, shoulders, flanks, legs, belly and croup (rump).
	Stable fly	3.25 to 6.5 fl.oz. per application	14 to 21 days	Stable flies bite chiefly about the legs. Apply to legs, ankles and belly
	Horn fly	3.25 to 6.5 fl.oz. per application	14 to 21 days	Horn flies hover over the backs, withers, and belly. Apply to withers, flanks and belly.
	Gnats	3.25 to 6.5 fl.oz. per application	14 to 21 days	Gnats hover about the eyes, ears, and nostrils. Treat face, ears, poll, jaw, and neck. Avoid contact with eyes and muzzle (mouth and nostrils).
	Face fly	3.25 to 6.5 fl.oz. per application	14 to 21 days	Face flies cluster on the head. Treat face, ears, poll, jaws and neck. Avoid contact with eyes and muzzle.

### Whole Body Spray:

- Dilute concentrate with water for use as a whole body treatment for mosquitoes, ticks, and horse sucking louse (lice).
- Measure the proper amount of product, pour the product into the sprayer, and add the appropriate amount of water.
- Use a 1:4 ratio with water by mixing 1 gallon of product with 4 gallons of water (one gallon of product provides five gallons of spray solution). Apply 1 to 2 pints of spray emulsion per animal.
- Treat animal thoroughly or cover the entire surface area of the animal (See Table 1). Avoid contact with eyes and muzzle (mouth and nostrils).
- Repeat the application at 14 to 21 day intervals if needed, if infestation persists, or if prescribed by veterinarian.

**Table 2. Application Instructions of Gordon's Horse and Pony Spray for direct applications as whole body sprays to horses and ponies.**

Treatment Method	Pest Controlled	Application rate, fl.oz. of product per adult animal	Retreatment interval, days	Instructions
Concentrate Diluted with water as whole body spray.	Mosquitoes	Use 1:4 dilution	14 to 21 days	Treat entire animal or apply for complete coverage.
	Horse sucking louse (lice)	Use 1:4 dilution	14 to 21 days	Lice are most common about the head, neck, and base of the tail. Even if few lice are found, treat entire body.
	Ticks	Use 1:4 dilution	14 to 21 days	Treat the animal thoroughly with 1 to 2 pints of spray applied per animal.

## Getting Started

**How To Use:** Use as a mist, wipe-on, or whole body spray insecticide

**Ready-To-Use Mist:** Use undiluted as a localized or spot treatment applied with mist/trigger sprayers. For listed flies and gnats, use 3.25 to 6.5 fl.oz. per adult animal every 14 to 21 days.

**Wipe-On:** Use undiluted as a localized or spot treatment as a wipe-on with an applicator mitt or clean towel.

**Whole Body Spray:** Use 1:4 dilution with water every 14 to 21 days for mosquitoes, horse sucking lice or ticks.
