Label in Compliance with 2,4-D Reduction Program

The proposed amendments to the labeling of the subject product have been reviewed for compliance with the terms and conditions as reached in the agreement between the Industry Task Force II on 2,4,-D Research Data and this Agency. The amendments are acceptable for registration under Section 3 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended provided that you:

1. Under DIRECTIONS FOR USE, delete the last sentence of the paragraph that begins with "The product can only be used...." since this product is only used for manufacture of products for residential and turf uses.
2. Following the heading FOR RESIDENTIAL AND TURF USES add the phrase, parenthetically, "Not Including Sod Farms."
3. Under FOR RESIDENTIAL AND TURF USES add the following sentence after "For Amine Liquid Products carrying...." "It is recommended that safety glasses include front, brow and temple protection."
3. Submit five (5) copies of the final printed labeling before releasing the product for shipment.

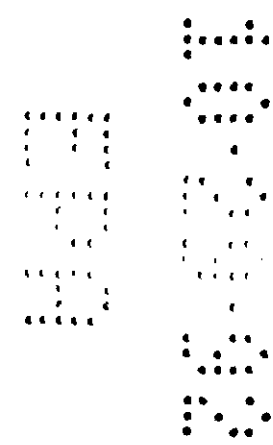

**PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS & DOMESTIC ANIMALS:**

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Instructions must be followed in strict accordance with the manufacturer's recommendations for formulating use.

This product can only be used to formulate pesticide products if the labeling contains the following information and/or revised use directions. All products manufactured for residential and turf uses after June 15, 1994, must contain the revised label language below. All other products (i.e., agricultural, industrial and aquatic), manufactured after October 23, 1993 must bear the revised label language below.

**GENERAL REQUIREMENTS FOR END-USE PRODUCT LABELING**

1. Containers over 1 gallon and less than 5 gallons in capacity must bear the following statement: "Persons engaged in open pouring of this product must also wear coveralls or a chemical resistant apron."
2. Containers of 5 gallons or more in capacity must also bear the following statement: "A mechanical system (probe and pump) must be used for transferring the contents of this container. If the contents of a non-refillable pesticide container are emptied, the probe must be rinsed before removal."

**3. FOR RESIDENTIAL AND TURF USES**

- a. Clothing Requirement Statements: 1) For All Granular Products: "When using this product, wear long-sleeved shirt, long pants, socks and shoes." 3) For Amine Liquid Products carrying "WARNING" or "DANGER" signal word: "When using this product, wear long-sleeved shirt, long pants, socks, shoes, rubber gloves and eye protection."

- b. **Personal Hygiene Statements:** 1) For All Granular Products: "After using this product, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water."; 2) For All Liquid Products: "After using this product, rinse gloves before removing, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water. Remove saturated clothing as soon as possible and shower."
- c. The maximum application rate to turf is the lower of 1) existing application rate on currently registered label or 2) 2 pounds 2,4-D acid equivalent per application per site. The maximum number of broadcast applications per treatment site is 2 per year.
- d. The following reentry statement must be included: "Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treatment areas until spray has dried or dust has settled."

#### **STORAGE & DISPOSAL**

**STORAGE:** Store in original container in a locked storage area inaccessible to children or pets. Keep from freezing. To prevent cross-contamination, do not store near other herbicides, fertilizers, insecticides, fungicides, or near seeds.

**PRODUCT DISPOSAL:** Do not contaminate water, food, or feed by storage or disposal. Pesticide wastes are toxic. Improper disposal of excess pesticide spray mixture, or rinsate is a violation of Federal Law and may contaminate groundwater.
