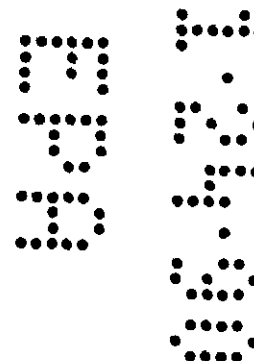

WASPS, HORNETS, AND DIGGER WASPS - This product will spray large droplets of insecticide six to eight feet from the spray tip. Where wasp nests are known to be present, treat after dark when all insects are on the nest. Retreat to avoid stings. Repeat as needed for control. Treat digger wasp (Cicadae killers) entry ways into the soil after dark and seal the opening with dirt. Repeat at needed.

CLOVER MITES - Clover mites may invade the home in cool weather and appear on windowsills where they become unsightly. They do no harm, but are extremely bothersome. Spray the outside windowsills only, also areas where the mites may enter porches, windows, and halls. Repeat treatment as needed. Do not apply to screens.
