This amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable, provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

- a. On the front panel add "For outdoor home use only."
- b. Under DIRECTIONS FOR USE change "Federal Law" to "Federal law".

3. Submit three (3) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for ~~shipment~~ ^{sale} of the product constitutes

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Avoid contamination of food or feed. Do not use on household pets or humans. Remove pets from area, and cover fish bowls before spraying. Statement of Practical Treatment

If Swallowed: Call a physician immediately. **DO NOT INDUCE VOMITING UNLESS NO OTHER TREATMENT IS AVAILABLE.** Vomiting may cause aspiration pneumonia. If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Do not induce vomiting or give anything by mouth if person is unconscious or convulsing.

If Inhaled: Remove victim to fresh air and apply artificial respiration if indicated. Get medical attention.

If on Skin: Wash promptly with soap and water. Get medical attention.

If in Eyes: Rinse eyes with plenty of water and call a physician immediately.

Note to Physician: This product is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine. This product contains petroleum distillate solvent, which may present an aspiration hazard. Gastric lavage may be indicated if product was taken internally.

Environmental Hazards

This pesticide is highly toxic to birds, fish, and other wildlife. Birds feeding or drinking on treated area may be killed. Keep out of lakes, streams, ponds, tidal marshes and estuaries. Do not apply directly to water. Do not contaminate water by disposal.

This pesticide is highly toxic to bees exposed to direct treatment or to residues on blooming plants where they feed. Do not allow this pesticide to drift to blooming plants if bees are visiting the treatment area. Do not apply this product to or allow it to drift to food crops or any desirable vegetation at any time.

Precautions: (1) Spray with the wind to your back. If clothing becomes wet from spray during use, remove clothing after spraying, wash affected body areas thoroughly with soap and water, and launder clothing before wearing again. (2) Do not allow children or pets to contact treated areas until spray has dried. (3) Do not apply to lawns or other desirable plants.

Application

Flies, Mosquitoes, Wasps, Flying Moths: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter. Treat dark corners and localized resting areas, under eaves, on porches, around patios, and garages. Repeat as necessary. Also treat surfaces around light fixtures on porches, and other places where these insects alight or congregate.

Chiggers, Ants, Brown dog ticks, Clover mites: For treatment of localized infestations of insects in outdoor areas, spray infested areas. Do not apply to lawns or other desirable plants. For ants, wet hills and runways. Repeat as necessary.

Porches, Patios, Garages, and other areas around the house where insects hide and congregate: To help keep flies, mosquitoes, wasps, and flying moths from entering the house, treat outdoor areas where these insects congregate. This treatment can be an effective addition to total pest control.
