Precautionary Statement

The labeling referred to above, submitted in accordance with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable with the following provisions:

1. Under the Statement of Practical Treatment replace the eye and skin statements with the following:

"IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists."

2. Add the following statement to remove this product from the scope of PR Notice 93-7 (Worker Protection Standards):

"Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes."

3. Under the Precautionary Statements, in the Hazards to Humans and Domestic Animals section, the eyewear statements (the last two sentences in the first paragraph), should be combined with the fourth sentence in the paragraph to read as follows: "When mixing, loading, or applying this product, wear long-sleeved shirt, long pants, socks, shoes, chemical resistant



ORNAMENTAL LAWNS & TURF (other than bentgrass): Apply Trimec® 891 Broadleaf Herbicide at the rate of 3½ to 4 pints per acre in sufficient water for adequate coverage. Maximum control of weeds will be obtained from spring or early fall applications when weeds are actively growing. Avoid applying during long excessively dry or hot periods unless adequate irrigation is available. Do not irrigate within 24 hours of application. Do not apply to newly seeded turf until after the second or third mowing. Grass seed can be sown 3 to 4 weeks after application at recommended rate. Do not use on dichondra and carpetgrass.

The maximum application rate to turf is 1.3 pounds 2,4-D acid equivalent per acre per application per site. The maximum number of broadcast applications per treatment site is 2 per year.

BENTGRASS TURF: In closely mowed bentgrass (putting and bowling greens) apply Trimec® 891 Broadleaf Herbicide at a maximum rate of 1 fluid ounce per 1,500 square feet, preterably in May or mid-August through September. Slight turf yellowing will disappear after about one week.

NOTE: Care should be taken to avoid overdosing bentgrass or injury may result. Large volumes of spray water (i.e., 1 fluid ounce in 5 gallons of water per 1,500 square feet) will aid in obtaining uniform coverage. If hand-type sprayers are used, it is preferable to use a single nozzle sprayer rather than a multiple nozzle boom. Sweeping movements with a multiple nozzle boom will result in heavy local over-application and subsequent turf discoloration or injury.
