- 1. 

Apply Trimec® 891 Broadleaf Herbicide to broadleaf weeds that are actively growing. Follow-up applications may be required for dense infestations of perennial and biennial weeds. Do not apply this product to 'Floratam' St. Augustinegrass.

#### NEWLY SEEDED AREAS:

The application of Trimec® 891 Broadleaf Herbicide to grass seedlings is recommended after the second mowing

#### NEWLY SODDED, SPRIGGED, OR PLUGGED AREAS:

The application of Trimec® 891 Broadleaf Herbicide to newly sodded, sprigged, or plugged grasses should be delayed until 3 to 4 weeks after the sodding, sprigging, or plugging operations. Also, applications to dormant bermudagrass, dormant zoysiagrass, and dormant bahiagrass are suggested.

#### **APPLICATION RATES FOR SOD FARMS:**

Dosage rates and spray volume recommendations of Trimec® 891 Broadleaf Herbicide for use in commercial sod production are presented in Table 1.

Generally, the lower application rates within the specified range will provide satisfactory control of sensitive weed species. The higher application rates within the specified range will be required for dense infestations of perennial weeds, for adverse/extreme environmental conditions, or for weeds beyond the appropriate growth stages.

#### HOW MUCH TO USE:

**For Kentucky Bluegrass, Fescue spp., Perennial Ryegrass, Bermudagrass and Zoysiagrass:** Apply 3.25 to 4.0 pints of Trimec® 891 Broadleaf Herbicide per acre with spray volumes ranging from 5 to 220 gallons per acre. Or, apply 1.2 to 1.5 fluid ounces of Trimec® 891 Broadleaf Herbicide per 1,000 square feet with spray volumes ranging from 0.5 to 5.0 gallons per 1,000 square feet of turf. Do not irrigate within 24 hours of application. The best time to control clover is in the fall. When making a spring application to control clover a 4 pints per acre rate is recommended.

#### For Bentgrass:

Apply a maximum rate of 1.8 pints of Trimec® 891 Broadleaf Herbicide per acre with spray volumes greater than 145 gallons per acre. The equivalent application rate would be 1.0 fluid ounce of Trimec® 891 Broadleaf Herbicide mixed with 5.0 gallons of water and applied to 1,500 square feet.

Note: Schedule applications during May or mid-August through September. Slight turf yellowing will disappear after about one week. Care should be taken to avoid overdosing bentgrass or injury may result. High spray volumes will provide uniform coverage.

#### **USE PRECAUTIONS:**

- Do not apply this product through any type of irrigation system.
- Some hybrid bermudagrass may be sensitive to this product. Contact your local Extension Service Weed Control Specialist. Do not spray on carpetgrass, dichondra nor lawns or turf where desirable clovers are present. Clover present will be damaged if sprayed.
- Do not apply this product to St. Augustinegrass or centipedegrass during spring green-up which is the transition period between dormancy and active growth. Turfgrass injury can be expected when used on centipedegrass or St. Augustinegrass lawns; spot spray weeds only on these types of grasses.
- Use only lawn type sprayers. Do not exceed specified dosages for any area.
- Do not apply to newly seeded grasses until well established. Do not apply to newly seeded turf until after the second or third mowing.
- Avoid applying during long excessively dry or hot periods unless adequate irrigation is available. Do not broadcast apply when air temperatures exceed 85°F; some injury may be expected with spot treatments when air temperatures exceed 85°F.
- Seed can be sown 3 to 4 weeks after application at the recommended rates.

#### Limitations on broadcast treatments for ornamental turfgrass and sod farms:

The maximum application rate is 4.0 pints of product per acre per application (1.19 lb 2,4-D ae, 0.32 lb MCPP-p ae, and 0.11 lb dicamba ae per acre per application). For ornamental turfgrass, the maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. For sod farms, the maximum number of broadcast applications is limited to 2 per year with a minimum of 21 days between applications. The maximum seasonal rate is 8.0 pints of product per acre (2.38 lb 2,4-D ae, 0.63 lb MCPP-p ae, and 0.21 lb dicamba ae per acre).

#### Limitations on spot treatments to residential turfgrass:

Spot treatment is defined as a treatment area no greater than 1,000 sq.ft. per acre. The maximum application rate is 1.5 fl.oz. per 1,000 sq.ft. per application (0.32 lb MCPP-p acid equivalent per acre). The maximum number of spot treatments is limited to 2 per year with a minimum of 30 days between applications.

#### Spray Drift Management

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of ground application can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

#### **Droplet Size**

Use only Medium or coarser spray nozzles according to ASAE (S 572) definition of standard nozzles or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

#### Wind Speed

#### Equipment

Repeat this procedure two more times.
