The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Revise directions for use in food processing areas to read as follows, and delete all directions that detract from the following directions:

Food must be removed or covered during treatment. In food processing areas, all utensils, shelving, etc. where food will be handled must be covered or removed before treatment or thoroughly washed with an effective cleansing compound followed by a potable water rinse prior to use.

Add a footnote to the ingredients statement as follows: Contains petroleum distillate.

Since the file jacket for this registration does not contain information about dielectrical breakdown voltage, add a Physical and Chemical Hazards Statement as follows:

Do not apply this product in or on electrical equipment due to the possibility of a shock hazard.

Revise the "If Swallowed" first aid statement as follows:

If Swallowed: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

Unless this product is packaged in a container less than 5 gallons in size, revise the Environmental Hazards statement to read as follows:

This product is toxic to fish, birds and other wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance, contact your State Water Board or Regional Office of the EPA.

Add to the Precautionary Statements the following: Wash thoroughly with soap and water after handling.

**STORAGE:** Store in original container in a locked storage area inaccessible to children or pets. Keep from freezing.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** For metal containers: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. For plastic containers: Triple rinse (or equivalent). Institutional Area Spray is a ready-to-use insecticide to be used in appropriate spray equipment (fog applicators, sprayers, vaporizers or other dispensers) according to the following directions.

Before using this product, exposed food products and packing materials must be removed from the room or protected. After using this compound, equipment and utensils must be thoroughly rinsed with potable water before operations are resumed.

When using in a confined area, vacate treated area and ventilate when treatment is completed.

#### FOOD PROCESSING PLANTS AND INSTITUTIONS:

Food should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product as a space spray in these areas, apply only when plant is not in operation.

#### ROACHES, WATERBUGS, ANTS, SILVERFISH, AND SPIDERS:

Apply as a coarse spray to all cracks and crevices where these insects normally hide. Spray behind pipes, beneath sinks and along runways infested with roaches, waterbugs, ants, silverfish and spiders recommended. Hit these insects with spray whenever possible. Repeat application as often as required.

#### **BEDBUGS:**

Spray bed frames, springs, and all sides of mattresses, especially seams and tufts. Spray behind baseboards, loose wall paper and into all cracks around the room where this insect may hide and breed. Repeat application when necessary.

#### **CLOTHES MOTHS AND CARPET BEETLES:**

Use as a fine spray. Remove infested articles from storage. Apply spray to closets, bureaus, chests, and other storages by directing into cracks, joints, and crevices. Repeat treatment every 30 days unless articles are stored in moth-tight containers. For Carpet beetles in food processing plants treat same as roaches.

#### FLIES, MOSQUITOES AND GNATS:

Use as a mist spray. Close room and discharge spray throughout room. Use 1 ounce of spray for each 1,000 cubic feet of space. Leave room closed for at least 10 minutes. Sweep up fallen insects. Repeat application when necessary. Avoid direct contact with food or food utensils. Vacate treated areas and ventilate before reoccupying.

#### STORED PRODUCTS IN ELEVATORS, GRANARIES, WAREHOUSES, AND MILLS:

For control of the exposed stages of Field Crickets, Granary Weevils, Confused Flour Beetles, Grain Moths, Cadelles, Rust Red Flour Beetles, Saw Tooth Grain Beetles, Spider Beetles, Grain Mites, Rice Weevils, and Cheese Skipper Flies:

After thorough cleanup and prior to filling with grain apply at the rate of 1 gallon for each 1,800 square feet of area. Wet surfaces of the storage area thoroughly. Hit insects directly with the spray whenever possible. Repeat application as often as necessary. Do not apply directly to grain or oil bearing seeds.
