

### 2. Broadleaf Weeds / Where To Use

Gordon's Broadleaf Weed & Brush Killer 879 may be used on bahiagrass, bermudagrass, bluegrass, fescue, perennial ryegrass or zoysiagrass lawns, vacant lots, playgrounds where broadleaf weeds are present. This product is especially effective on hard-to-kill weeds such as poison ivy, poison oak, sheep sorrel and spurge. In addition, it controls most other broadleaf weeds, including sensitive weeds like chickweed, clover, dandelion, knotweed, and plantain. [A partial list is given on the side panel.]

#### Limitations on broadcast applications to residential turfgrass:

The maximum application rate is 3.0 fl.oz. of product per 1,000 sq.ft. per application (0.88 lb 2,4-D ae, 0.21 lb MCPP-p ae and 0.10 lb dicamba ae per acre per application). The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 6.0 fl.oz. of product per 1,000 sq.ft. (1.77 lb 2,4-D ae, 0.43 lb MCPP-p ae and 0.20 lb dicamba ae per acre).

### WHEN TO USE:

- 1. Spray during the growing season when weeds are actively growing.
- 2. On new lawns, wait until the grass has reached a height of 2 inches before making an overall spray treatment. Wait 3 to 4 weeks before seeding or planting stolons, plugs, or sprigs.
- 3. Poor weed control may result if spray is applied during drought or just before rain.
- 4. For best results, mow before treating.
- 5. Do not water lawn within 24 hours after treatment.

# 3. How Much To Use (Entire Lawn) Hose End Sprayer

Use a hose end sprayer designed for lawns. Put specified amount of product (Column 1) in bottle and add water to indicated level (Column 2), and spray on area shown (Column 3). For example, to spray 850 square feet measure 5 tablespoons (2.5 fluid ounces) in jar, add water to the 5 gallon level, mix, and turn on hose and spray over 850 square feet

## 5. How Much To Use (Spot Treatment)

[To spray small areas or individual weeds, do not use a hose end sprayer. Mix 1 fluid ounce (2 tablespoons) with a half-gallon of water in pressure sprayer and spray as required being certain to wet each weed.]

[Apply 1.5 to 2.2 gallons of product per acre with adequate water or apply a 1.2 to 4.6% %vol/vol spray solution as a full cover spray.
