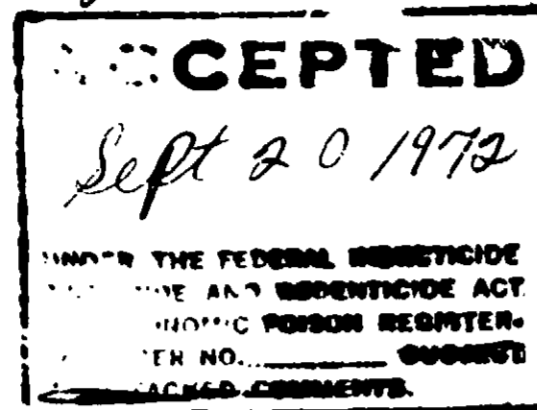


DIRECTIONS: To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and the like apply 1 to 4 gallons per 1000 square feet of Improved Perma Kill No Drift after the most predominant weeds have emerged. No agitation is required. Improved Perma Kill No Drift can be applied with standard spray equipment. For treating small areas, a tank type hand sprayer or sprinkling can may be used.

NOTE: Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of Improved Perma Kill No Drift in their particular area.
