The amendments are acceptable for registration under Section 3 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended provided that:

- l. You delete the third sentence (in the second paragraph of the "Directions for Use" section) that reads:

 " All other products"; and add the statement: "To be formulated into herbicide products for use on residential and turf (excluding sod farms) only."
 - 2. You delete the "3." preceeding the heading "For Residential and Turf Uses".
 - 3. The ingredient statement is revised to read: "Active Ingredients:", use the plural of ingredient, as there are more than one.
 - 4. Submit five (5) printed copies of the final printed labeling before releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 6(e). Your release for shipment of the porduct constitutes acceptance of these conditions.
