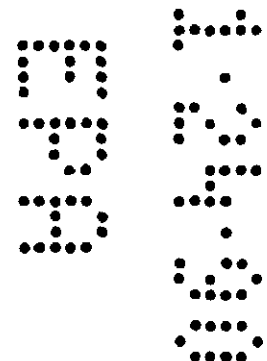

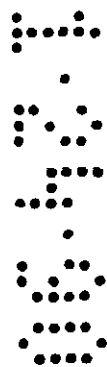

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food, or feed by storage or disposal. Store in original container in a locked storage area inaccessible to children or pets. Keep from freezing.

DILUTION: A special industrial emulsifiable concentrate providing a stable emulsion when diluted with water. Mix with water at rate of one gallon of concentrate to four gallons of water. Shake well before using. One gallon of the concentrate is diluted with four gallons of water and applied at the rate of one gallon of the finished spray to approximately 1,000 square feet of surface. Apply liberally as a coarse spray to all areas over which the insects might crawl. Direct the spray into cracks and crevices hitting as many insects as possible. Repeat as necessary.

When used as directed, this material will aid in the control of exposed stages of the confused flour beetles, cadelle, flat grain beetles, meal worms, dermestids, roaches, silverfish, Mediterranean flour moth and Indian meal moth.

The use of this product in food processing establishments should be confined to periods when the plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation.
