

Particular attention should be given to cracks, crevices and other hiding places. For best results apply spray direct to insects.

FOR SPACE SPRAY: Dilute 1 gallon of Gordon's Industrial Spray with 1 1/2 gallons of deodorized base oil and apply as fog or space spray using 1 gallon per 40,000 cubic feet (3 ounces in 1,000 cubic feet) for the control of houseflies, mosquitoes, and gnats.
