

**GORDON'S Golden Decoy Fly Bait consists of several natural attractants and special dark decoy pellets to attract flies to baited areas.**

### **DIRECTIONS FOR USE**

**Observe where flies congregate or breed and treat these areas. Scatter bait at a rate of ¼ pound per 500 square feet. Best results are obtained when scattered on dampened surfaces. Wet burlap may be baited for convenient clean-up. DO NOT apply in piles. Repeat applications may be necessary in 3 to 5 days.**

**Use in and around Livestock and Dairy Barns, Stables, Loafing areas, Feed Lots, Hog Farms, around Garbage Disposals, and outside areas of certain commercial buildings where flies become a nuisance.**

**Poultry Houses:** Apply bait on droppings under cages, walkways, and alleyways.

**Kennels:** Apply bait to walkways and other areas surrounding animal runs.

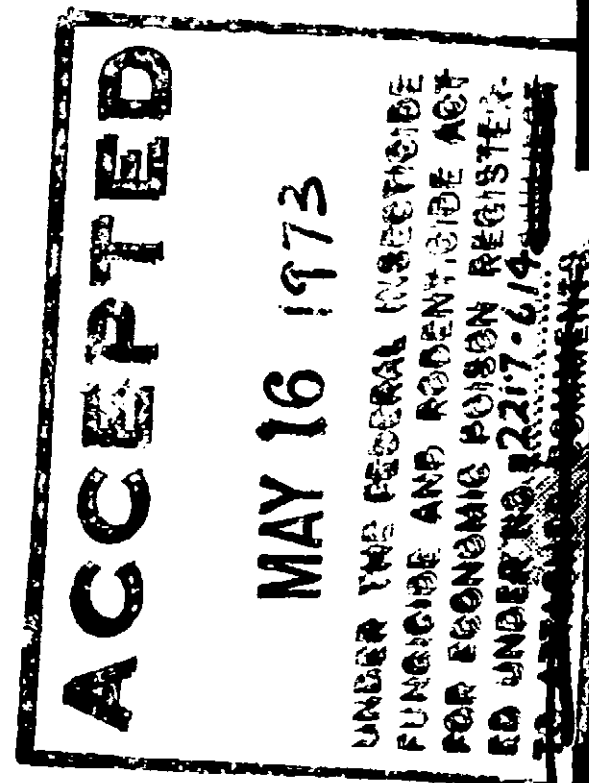
**Outdoor Use:** Apply bait on floors, walks, alleyways, and other horizontal surfaces where flies congregate; around Restaurants, Drive-Ins, Ice Cream Stands, Outdoor Latrines, and Compost areas.

**Outdoor Patios:** Apply bait along edges or where bait will not be tracked indoors. Make application the day before planning to use the patio for best results.

**Bait can be used to control flies around flower beds and ornamentals.**

**For maximum fly control use bait at the recommended rate and maintain good sanitation practices.**
