#### **APPLICATIONS OF GARDEN WEEDER:**

Controls crabgrass, purslane, lambsquarters, redroot pigweed, common chickweed, spotted spurge, annual grasses and broadleaf weeds. Does not control ragweed or smartweed.

May be used around and under shade trees, evergreens, flowering shrubs, and hedge rows. Also, may be used in groundcovers such as ivy and pachysandra. Do not use on dichondra. Does not prevent growth into treated areas by turfgrass.

May be used effectively in rose beds and in iris and gladiolus plantings.

Treat annual flowers after transplanting from flats or after thinning and initial weeding. Do not treat immediately after seeding petunias, snapdragons, and similar flowers.

A second late summer or fall application gives year around weed-free plantings.

Do not use on or near the following plants:

Use around tulips, amaryllis, and hosta is questionable not recommended.

#### **HOW TO USE:**

- 1. Existing weeds must be removed in early spring or treatment made on freshly cultivated ground.
- 2. Measure area to be treated and determine the number of square feet. If area to be treated is large, it should be divided into smaller sections of 10 square feet each.
- 3. Apply 1 pound per 100 square feet. Sift over soil uniformly.
- 4. Do not treat dry, hard soil, and do not cultivate after application.
- 5. Water lightly after application.

The following species of ornamentals, shrubs, and flowers can be treated. Apply 1 2/3 ounces (5 level tablespoons) of product per 10 square feet. One (1) pound of product treats 100 square feet.

#### STRAWBERRIES:

New planting - Apply overall immediately after transplanting.

Established Planting - Apply in the fall and early spring before weeds emerge. Do not apply after first bloom. Apply 11/3 ounces (4 level tablespoons) of product per 10 square feet. This one (1) pound container treats 120 square feet.

#### **VEGETABLES:**

Treat snap beans as soon as planted. Use around onion sets and after transplanting cabbage, cauliflower, broccoli, sweet potato slips, and tomatoes. On tomatoes, defer treatment 4 to 6 weeks after transplanting. Clean cultivate before making application. Apply 11/3 ounces (4 level tablespoons) of product per 10 square feet. This one (1) pound container treats 120 square feet.
