The proposed amendments to the labeling of the subject product have been reviewed for compliance with the terms and conditions as reached in the agreement between the Industry Task Force II on 2,4,-D Research Data and this Agency. The amendments are acceptable for registration under Section 3 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended provided that you:

- 1. Under DIRECTIONS FOR USE, delete the last sentence of the paragraph that begins with "The product can only be used...." since this product is only used for manufacture of products for residential and turf uses.
- 2. Following the heading FOR RESIDENTIAL AND TURF USES add the phrase, parenthetically, "Not Including Sod Farms."
- 3. Add a STATEMENT OF PRACTICAL TREATMENT to your label. The following should be added:

If Swallowed: If patient is conscious and alert, give 2-3 glasses of water or milk to drink. If available, give one tablespoon of Syrup of Ipecao to induce vomiting. Alternatively, induce vomiting by touching back of throat with finger. Get medical attention. Do not induce vomiting or give anything by mouth to an unconscious person.



If on Skin: Wash skin with plenty of soap and water, if available, while removing contaminated clothing. Wash clothing separately before reuse.

If in Ryes: Hold eyelids open and flush with a steady, gently stream of water for at least 15 minutes. Get medical attention.

## NOTE TO PHYSICIAN

No specific antidote is available. All treatment should be based on observed signs and symptoms of distress in the patient. Overexposure to materials other than this product may have occurred.

4. Submit five (5) copies of the final printed labeling before releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 6(e). Your release of the product for shipment constitutes acceptance of these conditions.
