DIRECTIONS FOR USE

RABON* Dust 3% is a ready-to-use insecticide which can be applied by hand or through the use of self-treating dust bags. There is no withholding period from last application to slaughter.

BEEF CATTLE AND DAIRY CATTLE: For the control of Horn Flies and Lice and aid in the control of Face Flies.

HAND DUSTING—Apply approximately 2 ounces of dust by shake can, rotary duster, or by spoon to the upper portions of the back, neck and poll, and to the face as an aid in the control of Face Flies. Rub in lightly to carry the dust beneath the hair, Repeat as necessary.

SELF-TREATING DUST BAG—FORCED USE—Put RABON® Dust 3% in cotton cloth or double burlap bags or use pre-packed weatherproof cattle dust bags and hang in barn door exits or alleyways leading from animal buildings, salt or mineral blocks, or watering holes. Protect cloth or burlap from weather.

SELF-TREATING DUST BAG—FREE CHOICE USE—Use the same dust bags as above but place in loafing sheds, holding pens, feedlots, near watering holes, or other areas where cattle gather. The free choice use aids in the control of lice.

CAUTION: Harmful if swallowed. Avoid breathing dust. Do not get in eyes, on skin, or on clothing. If the material gets into the eyes, wash with plenty of water for 15 minutes; if irritation persists, see a physician. Wash thoroughly with soap and water after handling and before eating or smoking. Avoid contamination of feed and foodstuffs. Keep away from heat and open flame. Do not apply in dwellings.
