





RQADSIDES, DRAINAGE DITCH BANKS, FENCEROWS, RIGHTS-OF-WAYS, FARM BUILDINGS AND OTHER SIMILAR NON-CROP AREAS:

To effectively control brush, all leaves, stems and suckers should be thoroughly wet to the ground. Apply when plants come into full leaf (spring) to the time plants begin to go dormant. Best results are obtained when brush and weeds are young and actively growing. Do not cut brush or weeds until the herbicide has translocated throughout the plant causing root death.
