

**PRECAUTIONARY STATEMENTS**

**Hazards to Humans and Domestic Animals**



**STORAGE & DISPOSAL**

**STORAGE:** Keep from freezing. Store in original container in a locked storage area inaccessible to children and domestic animals.

**PESTICIDE DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Pesticide wastes are toxic. 4. Do not spray roots of trees and ornamentals. Do not exceed specified dosages for any area; be particularly careful within dripline of tree and other ornamental species.
5. NOTE: Coarse sprays are less likely to wind-drift.
6. Do not spray while grass is emerging from dormancy.
7. Do not apply to newly seeded lawns until after the second or third mowing.
8. Do not spray when air temperature exceeds 85°F.
9. Seed can be sown 3 to 4 weeks after application.
10. Do not contaminate domestic or irrigation waters.
11. After using this product, clean sprayer with soap or detergent and water, and rinse thoroughly before applying other pesticides.
12. Failure to observe the above precautions may result in injury.
13. Do not apply this product through any type of irrigation system.

**NOTE:** Do not use on bentgrass, carpetgrass, dichondra or St. Augustinegrass.

**ORNAMENTAL LAWNS & TURF:**

Apply Gordon's 2,4-D/Dicamba Turf Herbicide at the rate of 1 to 2 pints of product per acre in 20 to 160 gallons of water. Maximum control of weeds will be obtained from spring or early fall applications when plants are actively growing. Avoid applying during long, excessively dry hot periods unless adequate irrigation is available. Do not irrigate within 24 hours of application. Do not apply to newly seeded turf until after the second or third mowing. Grass seed can be sown 3 to 4 weeks after herbicide application.

The maximum application rate to turf is 0.9 pounds 2,4-D acid equivalent per acre per application per site. The maximum number of broadcast applications per treatment site is 2 per year.


