



- Do not spray on bentgrass, St. Augustinegrass, dichondra, or carpetgrass lawns or turf, or where desirable clovers are present. Use coarse sprays as there is less chance of drift.
- Do not apply to areas underlaid by roots of desirable trees and shrubs.
- Do not contaminate domestic or irrigation waters.
- Always use separate equipment for insecticides and fungicides.

- RECOMMENDATIONS FOR TURF -

Use 2.0 to 3.0 pints Gordon's Amine 2,4-D Turf Herbicide in 10 gallons of water per acre. Or use 1.5 - 2.0 tablespoons of product per gallon of water per 1,000 square feet. Apply in spring when weeds are actively growing to obtain maximum control and again in early summer. Do not apply to newly seeded areas until grass is well established. Do not spray new lawns until after first cutting. Clover may be clamaged with this spray. Do not use on bentgrass, St. Augustinegrass, dichondra, or carpetgrass iawns.

The maximum application rate to turf is 1.5 pounds 2,4-D acid equivalent per acre per application per site. The maximum number of broadcast applications per treatment site is 2 per year.

DON'T OVERDOSE - Read the label directions and cautions carefully. Do not let spray drift to sensitive plants such as vegetables, grapes, flowers, or other 2,4-D susceptible plants: Boxelder and redbud trees are also injured by spray drift. Use a coarse spray and make treatments only when there is minimum chance of drift.

- RECOMMENDATIONS FOR NONCROPLAND -

To control broadleaf weeds along roads, rights-of-way, drainage ditchbanks, fencerows, and other similar noncrop areas, mix 2.0 to 3.0 pints of product in 20 gallons of water with 5.0 to 8.0 fluid ounces nonionic surfactant and thoroughly wet weed foliage. Treat in the spring and again just before bloom time before weeds go to seed. Repeat the following year.


